DECLARATION OF INDEFINI

DECLARATION OF INDEFINITE STRIKE OVER GOVERNMENT'S FAILURE TO FULLY
IMPLEMENT THE NLC ARBITRAL AWARD

The National Executive Committee (NEC), in consultation with the National Council of the Colleges of Education Teachers Association of Ghana (CETAG), at its emergency meeting held on 19<sup>th</sup> November 2025, has resolved to withdraw *ALL SERVICES* effective *Monday, 24<sup>th</sup> November 2025*. This decision follows government's failure to implement the National Labour Commission (NLC) arbitral award issued on 2<sup>nd</sup> May 2023.

CETAG remains committed to quality teacher education. However, the government's persistent indifference, disregard for binding agreements and failure to honour obligations under the NLC arbitral award of 2<sup>nd</sup> May 2023 have left the Association with no alternative but to activate this industrial action.

The strike has been necessitated by the government's refusal to address the following issues:

1. Non-Payment of All-Year-Round Work Compensation for additional duties performed

in 2022 for the remaining 39 Colleges of Education, with only partial payment made

to the Accra College of Education.

2. Outstanding Book and Research Allowance arrears for the 2023/2024 academic year.

3. Outstanding Book and Research Allowance arrears for the 2022/2023 academic year

4. Outstanding Book and Research Top-up arrears for the 2021/2022 academic year

owed to Akrokerri College of Education.

5. Downgrading of some experienced teaching staff who hold master's degrees in the

Colleges of Education, which undermines professional dignity and violates agreed

conditions of service and the Labour Act, 2003 (Act 651).

CETAG previously cautioned in its 27<sup>th</sup> October, 2025 press release that, continued

government inaction would leave the Association with no option but to resort to industrial

action. Regrettably, this warning has not been heeded, compelling CETAG to proceed with

the strike.

The NLC arbitral award of 2<sup>nd</sup> May 2023 is legally binding on the government and the failure

to implement it in full constitutes a breach of labour law and collective bargaining principles.

CETAG has exhausted all avenues for dialogue and can no longer tolerate such disregard for

due process and fairness.

CETAG wishes to state unequivocally that:

Members will **not** return to the lecture halls, supervise students on STS until all the

listed grievances are fully resolved.

The strike is a legitimate response to the government's breach of agreements and

disregard for the NLC arbitral award.

While CETAG remains committed to quality teacher education, it will not allow its

members to be exploited, disrespected, or further impoverished.

We call on all stakeholders, particularly the Ministry of Education, the Ministry of Finance

and the Government of Ghana, to act with the required urgency and good faith to resolve

these matters.

Industrial harmony and the future of teacher education in Ghana depend on your timely and

responsible response to our concerns.
