We the members of Birim Youth Association (BiYA), a youth group operating in the municipality respectfully write to petition your esteemed office to make public the findings of the investigation conducted into allegations of extortion of monies from some illegal miners operating in the Birim Central Municipal Assembly, an allegation made by the member of parliament for the constituency against the Municipal Chief Executive.

We have become aware that somewhere in February 2026, a petition concerning this allegation was brought to your office upon which the issue was referred to the Ministry of Local Government, Chieftaincy and Religious Affairs for subsequent investigation into the allegation by the National Investigations Bureau (NIB), which the report has been submitted.

Unfortunately, the continued repetition of these allegations by the honorable Member of Parliament on the various media platforms despite investigation been conducted, creates a situation where public opinion may be influenced by these accusations without the benefit of the official findings of a very competent state institution.
